Regular Meeting  
June 9, 2014

Erskine City Council met in regular session Monday, June 9, 2014 at 6:00 p.m. Present were Mayor Paul Noyes, Council Members: Wade Farrell, Jim Herdliska, Ira Hill and Marc Plante.

Motion by Plante seconded by Herdliska approved the agenda with additions. Carried.

Motion by Plante seconded by Farrell approved city minutes from May 12. Carried.

Motion by Herdliska seconded by Plante approved Ordinance #16, 2<sup>nd</sup> Series amending City Code Chapter 7 adding section 7.35 Golf Cart, All-Terrain Vehicle, and Utility Task Vehicle regulations; requiring an annual permit issued by the City at a cost of \$10.00. Carried with five ayes.

Motion by Plante seconded by Hill hired Kolton Stuhaug and Noah Klinkhammer for summer employment working 20 hours per week @ minimum wage. Carried.

Motion by Plante seconded by Farrell accepted the Community Center freezer bid from Gary Walter at a purchase price of \$50.00. Carried.

Discussion was held on street improvements to 1<sup>st</sup> Street, 2<sup>nd</sup> Street, and Elm Avenue. Motion by Farrell seconded by Herdliska approved a 2' overlay to 1<sup>st</sup> Street South from the intersection to Ward approximately 360' at \$14,700.00. Carried with Plante opposed.

Motion by Farrell seconded by Plante approved monthly bills in the amount of \$64,353.68. Carried.

Motion by Hill seconded by Plante approved WTP/Capital Project bills in the amount of \$1,200.58. Carried.

Motion by Plante seconded by Herdliska approved the 2013 Fire Relief Association annual report. Carried.

Motion by Plante seconded by Farrell approved a quote from Electric Pump \$649.52 for pump repairs at the stabilization ponds. Carried.

Motion by Hill seconded by Plante appointed the following election judges: Beverly Nelson-head judge, Tina Farrell, Betty Herdliska, Hollie Stewart and Clerk/Treasurer. Carried.

Motion by Plante seconded by Hill approved purchasing 3 voting booths from United American Election Supply at 199.50 each. Carried.

Motion by Plante seconded by Herdliska authorized the Deuce Bar & Grill to have a street dance July 5, 2014. Carried.

Motion by Plante seconded by Farrell approved a special convention license for the Deuce Bar & Grill to serve at the Hornbuckle/Osmondson wedding reception at the Community Center August 16, 2014. Carried.

Motion by Plante seconded by Hill approved the Government Obligation contract with Kansas State Bank of Manhattan for the 2015 Ford Pickup. Carried.

Motion by Plante seconded by Hill accepted the Clerk/Treasurer resignation effective July 3, 2014. Carried.

Council reviewed applications received for the City Clerk. Interviews with two of the applicants were scheduled for Tuesday, June 10, 2014. Carried.

With no further business a motion was made by Farrell seconded by Plante to adjourn. Carried.
